Crime in Delaware: 2017 – 2021 is the official report of serious crimes known to Delaware law enforcement from 2017 through 2021. The report provides extensive data about crime at state and county levels. This supplement reflects an evolving effort within the *Crime in Delaware* reporting process to provide extensive crime data about the City of Wilmington.

The methods used to prepare and analyze Wilmington's data are the same as those described in the main *Crime in Delaware* report, with one exception: data for Wilmington's two enforcement agencies—the Wilmington Police Department and the Wilmington Fire Marshall were first merged before analyzing the city's data.

In this supplement, tables, and figures with summary level data about offenses, clearances, and arrests are presented first. These are followed by detailed data tables with counts of offenses, clearances, and adult and juvenile arrests (Tables 3 - 6). Summaries of key findings from each level of data are also included and precede the two sections.

Note: Caution should be used when comparing criminal offense trends involving 2020/2021 totals. Due to the COVID-19 pandemic and subsequent State of Emergency declarations, court closings, and travel restrictions within the State of Delaware, it is not possible to discern if, or how much, those events impacted year-to-year changes in offense totals.

Note: During NIBRS data research in early 2022 it was found that Identity Theft and Hacking/Computer Invasion offense totals were not being calculated correctly in the reporting used to create the *Crime in Delaware* reports. While overall Fraud offense totals were calculated correctly, the individual sub-category totals changed drastically for 2021.

Wilmington Serious Crime At-a-Glance 2017 – 2021

Overall, 1,848 fewer Group A offenses were reported in Wilmington in 2021 compared to 2017, a decline of 16.4%. This continues a long downward trend, aside from a slight increase in 2016 (see Table 1 and Figure 1). All major crime categories were lower in 2021 compared to 2017, with the greatest declines in Violent Offenses (20.9%) and Serious Property Offenses (26.1%). Drug Offenses and Other Property Offenses declined during this period by 7.3% and 4.1%, respectively. Long-term trends since 2010 can be seen in Figure 1A. Figure 1B shows the same long-term trends with a different scale in order to show detail of the four offense categories.

The most frequently reported offenses in the city were Assault; Larceny/Theft; Property Destruction/Vandalism; Drug/Narcotic; Fraud; and Weapon Law Violations. Fraud became one of the top 6 offenses in Wilmington in 2021, replacing Burglary. Assault, Property Destruction/Vandalism, and Drug Offenses continue a long overall downward trend. Larceny/Theft decreased 29.9% from 2017 to 2021 with varying ups and downs over the 5 years. Fraud showed a sharp increase from 2020 to 2021, and an overall increase from 2017 to 2021. Weapon Law Violations steadily increased from 2017 to 2021 with an overall increase of 2.1%. Long term trends since 2010 can be seen in Figure 2. The number of homicides in 2021 (40) is the highest tally in this report's history.

2021 offenses in all main crime categories were cleared at rates comparable to those from 2017 through 2020 (see Table 1 and Figure 3). Overall, 36% of all offenses committed in 2021 were cleared by the end of the calendar year with 52.9% of Violent Offenses cleared and 85.2% of Drug Offenses cleared. Long term clearance trends as recorded by the end of the calendar year can be seen in Figure 3.

The number of adult and juvenile arrests decreased from 2017 to 2021 (5.2% and 15.8%, respectively). Yearly arrest totals vary from year to year. Total arrests for Drug Offenses decreased over 22.4% from 2017 to 2021. The Drug arrest decline is comparable to the overall state arrest trends, and is partially attributed to the marijuana possession statute changes decriminalizing marijuana possession in certain situations and circumstances. Long term trends in arrests can also be seen in Figure 3.

Drug Offense Changes

Note: In December 2015, Delaware passed legislation that decriminalized certain marijuana possession offenses. Depending on various circumstances, these offenses are civil offenses. Due to the Federal Government still recording these offenses as criminal, they are part of the Drug Offense totals in this report. Depending on the circumstances surrounding those offenses, an arrest may not be made due to some possession offenses being deemed "civil offenses" by the State of Delaware.

A Detailed Look at Crime in Wilmington

The following section provides more detailed information about serious crime in Wilmington. Included is a summary of notable findings for specific crimes within the four crime categories (Violent Offenses, Serious Property Offenses, Drug/Narcotic Offenses, Other Property & Social Offenses) along with tables that provide detailed counts of Offenses, Clearances, and Adult and Juvenile arrests.

Violent Offenses

- The number of 2021 Criminal Homicides (40) is the highest since this report began in 2002.
- Forcible Sex Offenses were 64.1% lower in 2021 as compared to 2017, and a low for the 5-year report period.
- Assault and Robbery Offenses both decreased (16.5% and 43.8%, respectively) compared to 2017. Robbery Offenses are at an all-time low since this report began in 2002.
- Assault Offenses that involved the use of a firearm were 30.9% higher in 2021 compared to 2017 but did show a decrease of 15.6% from 2020 to 2021. Robbery Offenses involving a firearm are down 47.7%, a low since reporting started in 2002.

Note: In 2019 the FBI began including Vehicular Homicides under the Criminally Negligent Manslaughter category. Those offenses were not previously included in the NIBRS Homicide summary totals. This change added one offense to the Wilmington Homicide totals for 2021.

Serious Property Offenses

- Burglary offenses were 28.3% lower in 2021 compared to 2017.
- The number of all Larceny/Theft Offenses in 2021 was 29.9% lower compared with 2017.
- Within that subcategory of crime:
 - Theft of Motor Vehicle Parts/Accessories climbed 192.9% from 2017 to 2021, with the majority of this increase from 2020 to 2021.
 - The number of Theft from a Building Offenses was 29.7% lower than 2017.
 - The number of Shoplifting Offenses in 2021 decreased from a high in 2019, and 29.7% from 2017 totals.
 - The number of Theft from a Motor Vehicle decreased 49.3% since 2017.

Drug/Narcotic Offenses

- Total Drug Offenses in Wilmington were down 7.3% overall from 2017 to 2021.
- Drug/Narcotic Possession Offenses decreased 10% while Drug Equipment Offenses increased 12.1%.

Other Property and Social Offenses

- The number of total Fraud Offenses increased almost 103.5% from 2017 to 2021, the vast majority of this increased occurred from 2020 to 2021 (43.3%).
- The number of Property Destruction/Vandalism offenses decreased 18.1% and is at a 5year low.
- Weapon Law Violations were 2.1% higher compared to 2017.
